

## **High Risk Jurisdiction List: September 2025**

## **Explanatory Notes:**

- **CPI scoring and ranking for jurisdictions as per risk of corruption published by Transparency International** CPI scores are given on a scale of 0 (highly corrupt) to 100 (very clean). The CPI ranks 180 countries and territories. We have marked countries of particular high-risk in red i.e., scores of 40 and below: Corruption Perceptions Index 2024 Transparency.org
- OFSI Office of Financial Sanctions Implementation, UK issued financial sanctions regime list: OFSI Consolidated List Search
- **OFAC** Office of Foreign Assets Control, US Sanctions Programs and Country Information OFAC does not maintain a specific list of countries that U.S. persons cannot do business with: <u>Sanctions List Search</u>
  - U.S. sanctions programs vary in scope. Some are based geographically (i.e., Cuba, Iran), while others are "targeted" (i.e., counter terrorism, counter-narcotics) and focus on specific individuals and entities.
- **FATF** Financial Action Task Force, list of countries identified as High-Risk Jurisdictions "subject to a Call for Action" and Jurisdictions under "Increased Monitoring" aka "grey list" (country has committed to resolve swiftly the identified strategic deficiencies within agreed timeframes): "Black and grey" lists
- **UK List of High Risk Third Countries** The Money Laundering, Terrorist Financing and Transfer of Funds (Information on the Payer) Regulations 2017 (the 'MLRs') require the UK regulated sector to apply enhanced customer due diligence in relation to high-risk third countries. The list of high-risk third countries is detailed in Regulation 33(3)(a) of the Money Laundering Regulations 2017. The list replicates those countries listed by the Financial Action Task Force as high risk, or under increased monitoring. Money Laundering Advisory Notice: High Risk Third Countries GOV.UK
